

Unit on SMI[®] (Swiss Market Index) with reference bond Hewlett-Packard

PRODUCT DESCRIPTION

Unit with a reference bond (hereinafter also referred to as structured products with a reference bond) additionally refer to a reference bond compared to traditional Unit, in that certain events in respect of the reference bond (default or redemption event) may have a negative impact on the value and result in an early redemption (see "Early redemption or determination of a default or redemption event"). Provided that no default or redemption event occurs in respect of the reference bond, the function of this product corresponds to that of a traditional Unit, as specified below:

Unit are characterised upon expiry by capital protection on the one hand, and, on the other hand, by participation in the performance of the underlying. The redemption at the end of the term is determined on the basis of the final fixing of the underlying: If the final fixing of the underlying is above the strike price, an amount corresponding to the issue price multiplied by the performance of the underlying and by the participation is paid in addition to the capital protection. If the final fixing of the underlying is equal or below the strike price, the capital protection is repaid (for details see "Redemption/delivery" or "Redemption formula").

PROSPECTS OF PROFIT AND LOSSES

Structured products based on a reference bond:

Investors should be aware that the reference bond may have an adverse impact on the value of structured products with a reference bond, in that when a default or redemption event occurs in respect of the reference bond the structured products are redeemed early. The liquidation amount redeemed to the investor after determining or the occurrence of such a default or redemption event may be significantly lower than the issue price or, in extreme cases, even zero. Any possible gain results from the participation-related participation in the positive performance of the underlying. As a fundamental rule, the gain share is not subject to an upper limit. These products guarantee capital protection expressed in per cent at maturity: With non-100%-guaranteed products, the investor may receive less back than the issue price at maturity. It should also be noted that participation in the performance of the underlying is limited by the participation.

Even if the performance of the underlying is positive, the price of the product during the term may be considerably below the issue price. Risks in connection with the reference bond

Structured products with a reference bond are very sophisticated and complex financial products, which require a special understanding of the product and the risk. The value of this investment and the repayment depends, amongst other things, predominantly on the reference bond and indirectly on the reference bond issuer.
