The Title Universe consists of Swiss corporate stocks of the small- and midcap segment. The stocks are listed at a recognized exchange (World Federation of Exchanges or FESE (Federation of European Securities Exchanges)). None of the stock has a weighting larger than 10%. #### Rebalancing

The Investment Manager rebalances generally 12 times a year the portfolio composition based on its qualified evaluation of the market. The Rebalancing is based on net prices of the Underlyings (average of the net prices of the underlyings converted into the basket currency by the Issuer). The rebalancing period may be prolonged by the Issuer due to limited tradability. The current basket composition of the Underlying is listed in the Annex to this termsheet.

### Modifications
