Product Structure

The Turbo Put Warrant is a product that allows Investors to profit from the downward movement of the Underlying. They must be aware that the price of the instrument will move disproportionately more than the price of the Underlying.

As long as the Knock-Out Barrier has not been touched, the Investor will receive the difference between the Strike and the Settlement Price, adjusted for the Conversion Ratio, converted into the Redemption Currency, if applicable.

If the Knock-Out Barrier is touched at any time during the life, the Turbo Put Warrant expires immediately and worthless.

2. Prospects of Profits and Losses

Market Expectation Investors expect the Underlying to decrease in value over the life of the Product and accordingly expect to benefit from a leveraged performance relative to the Underlying. In any case Investors expect that no Knock-Out Event will occur.
